**Refund Policy:** Refunds will be issued if the parent has complied with the termination policy and an overpayment of tuition has been made on the account. Refunds will be granted only after bank documentation shows funds have cleared the customer's account. There will be no refunds on registration, activity or supply fees.

**\*Friday only Drop in is defined as no more than twice in a four week period.**

**Drop in care will have to be reserved no later than 2 business days prior with management approval.**

A non-refundable annual registration fee for the school year (Aug-May) is due and payable upon enrollment prior to beginning services. If not paid by the assigned due date, the enrollment slot will be released. Each subsequent school year, the registration fee is due by August 1st for the upcoming school year. The fees are \$125.00 per child or \$175.00 per family. If enrolled after September 1st the registration fee would be prorated for the remainder of the school year.

Children ages one year to five years old will be required to pay a summer enrichment registration fee at the beginning of each Summer if there is a specialized summer program being offered at the facility. If the specialized summer program is being offered, there is no option to opt out if attending the facility. This fee covers all internal and external field trips, materials and supplies for enrichment programs offered to your child at the Center.

\*Tuition schedule reflects our current tuition rates when paying via e-check, ACH Debit, check or money order. All forms of card payments (including but not limited to credit and debit cards) are subject to a 2.95% card processing fee.

State Discounted Tuition Rate (Eligible for Level 1 -3): Eligible level 1 and 2 families will receive a discounted tuition rate for all enrolled children, therefore the sibling discounted rate is not applicable.

Sibling Discounted Tuition Rate (Eligible for Level 4): Families enrolling multiple children will receive a discounted tuition rate. However, the discounted rate applies only to the eldest child. Please refer to the policy for more details including document verification.

Program tuition payments are always due in advance. Non-payment of program tuition will result in denial of services.

**There are no tuition reductions granted for absences, holidays, or lack of attendance in your requested program.** Tuition rates are subject to change with advance notice.
